MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Results of Operations

During the period, the net asset value of the Sun Life Sentry Value Class (the "Fund") increased from \$18.8 million to \$23.8 million. The increase in net asset value was due to positive net sales, as well as positive performance during the period.

During the period, the Fund returned 3.9% for Series A shares. This result surpassed the Fund's benchmark, the S&P/TSX Composite Index, which returned 0.7%. The performance returns for other series of this Fund are similar to those of Series A except for differences in expense structures. Please refer to the 'Past Performance' section of this report for performance of each series.

The Fund currently invests substantially all of its holdings in units of the Sun Life Sentry Value Fund (the "underlying Trust Fund"). The following commentary relates to the underlying Trust Fund.

The underlying Trust Fund's outperformance relative to the benchmark was primarily due to the underlying Trust Fund's allocation and positioning in Materials, Energy and Real Estate. During the period, the underlying Trust Fund's strongest contributor to relative performance was the Materials sector as the underlying Trust Fund benefitted from strong stock selection both in absolute terms and relative to the benchmark. The underlying Trust Fund also benefitted from an overweight allocation and strong stock selection in Real Estate, which was another key reason for outperformance during the period. Thirdly, the underlying Trust Fund's underweight allocation to the Energy sector was a strong relative contributor to performance during the period as the Energy sector struggled due to weak energy prices. The underlying Trust Fund's largest relative detractor was Financials, due to an underweight exposure and stock selection relative to the benchmark.

Recent Developments

The Canadian equity market as measured by the S&P/TSX Composite Index ended the period fairly flat, up just 0.7%. The S&P/TSX Composite Index was led primarily by Consumer Discretionary, Industrials and Utilities. Energy and

Materials were the only two sectors with negative performance during the period and were strong overall detractors to performance as they are both large weights in the Index.

Central banks and monetary policy continued to be a popular topic in North America and across global markets. In March, the U.S. Federal Reserve increased interest rates by 25 basis points and then followed the rate hike with another 25 basis point increase towards the end of the period. The Bank of Canada provided a positive tone in their June communication which led many to believe that a rate increase could occur soon as they hope to unwind the two emergency rate cuts that they implemented in 2015.

The broad Canadian economy appears to be improving as evidenced by several economic indicators, and in particular on the jobs front, which is part of the reason why the Bank of Canada communicated a positive tone towards increasing interest rates. Nominal gross domestic product has expanded for three consecutive quarters, and corporate profits have corresponding rebounded, which are positive signs for the Canadian economy.

In regards to currency, the Canadian dollar rallied towards the end of the period, experiencing a sharp appreciation relative to the U.S. dollar.

Sentry Investments Inc. (the underlying Trust Fund's sub-advisor, the "sub-advisor") evaluates the underlying Trust Fund's investments on a stock-by-stock level. As a result, sector weights or shifts are not necessarily indicative of a particular opinion (or change of opinion) on that sector, and sector weights are merely the result of security selection. The largest shift in sector exposure was in the Utilities sector, with a weight of 4.3% at the end of the period, up from 0.7%. This can be generally attributed to the sub-advisor taking advantage of attractive entry points to initiate positions in the sector. Another notable change in sector weight during the period was a decrease in exposure to Industrials from 14.0% to 11.0%. The cash weighting in the underlying Trust Fund also decreased, ending the period at 6.0%, down from 8.3%.

Effective February 5, 2016, all Series E and EF shares were converted to Series A shares, under the Front End Sales Charge option, and Series F shares, respectively, of the same

Related Party Transactions

Sun Life Global Investments (Canada) Inc. (the "Manager") is the manager and portfolio manager of the Fund.

The Manager is responsible for the provision of all general management and administrative services required by the Fund in its day-to-day operations, including providing or arranging for the provision of investment advice, bookkeeping, recordkeeping and other administrative services for the Fund.

For its services, the Manager receives a management fee that is calculated as a percentage of the average net asset value of the Fund. This fee is calculated daily and payable monthly.

As portfolio manager, the Manager is responsible for managing the investment portfolio of the Fund directly or through sub-advisors.

The Manager is an indirect wholly owned subsidiary of Sun Life Financial Inc.

Fund Administrative Expenses

The Manager pays certain of the operating expenses of each Fund (the "Administration Expenses") in return for a fixed administration fee paid to the Manager by each Fund ("Administration Fee"). The Administration Fee is based on the net asset value of each series of the Fund. The Administration Expenses include, but are not limited to, record keeper fees, accounting, audit and legal fees, bank and interest charges, safekeeping and custodial fees, taxes, administrative and systems costs, costs of reports to investors, prospectuses and other disclosure documents, regulatory filing fees (including those incurred by the Manager) and trustee fees for registered plans. The amount of this charge is disclosed as a fund administrative expense in the Fund's Statement of Comprehensive Income found in the semi-annual financial statements (unaudited).

Each Fund also pays certain operating expenses directly (the "Fund Costs"). Fund Costs include: borrowing costs incurred by the Fund from time to time; costs in connection with portfolio transactions; fees and expenses payable to or in connection with the Fund's Independent Review Committee ("IRC"); taxes payable by the Fund; and the costs of complying with any new regulatory or legal requirement imposed on the Fund. Each Fund allocates Fund Costs proportionately among its series of shares. The Fund Costs that are specific to a series of shares are allocated to that series. These amounts are paid out of the assets attributed to each series of shares of the Fund, which reduces the return you may receive.

Series Description

The Fund offers the following series of shares: A, AT5, F, I and O. The date of creation for Series A, AT5 and F shares was August 1, 2013, the date of creation for Series O shares was April 1, 2014, and the date of creation for Series I shares was May 1, 2015.

Series A and AT5 shares are available to all investors.

Series AT5 shares are designed to provide investors with a fixed monthly distribution based upon a target annualized distribution rate of 5% of the net asset value per share as at the end of the prior year.

Series F shares are available to investors who have a fee-based account with their dealer and whose dealer has signed an agreement with the Manager. Instead of paying sales charges, investors buying Series F shares pay fees to their dealer for investment advice and other services. The Manager does not pay any commissions to dealers in respect of Series F shares, so the Manager can charge a lower management fee.

Series I shares are special purpose securities that are currently only available to other mutual funds and eligible institutional investors. Series I shares are not sold to the general public. Each Series I investor negotiates its own management and advisory fee that is paid directly to the Manager.

Series O shares are available to investors through the Private Client program and must be purchased through a Private Client account. Each Series O investor pays a management fee directly to the Manager and is eligible for management fee reductions, if any, based on the value of Series O shares held in the investor's Private Client account. Series O management fee is paid, after subtracting any management fee reductions, by a redemption of Series O shares in the investor's account.

Management Fees

The annual maximum management fee paid by the Fund is a percentage of the average daily net asset value of each series exclusive of any applicable taxes and operating expenses, which is accrued daily and is paid to the Manager monthly in arrears. Management fees pay for portfolio and investment advisory services, oversight of any service providers, marketing and promotional activities, arranging for the distribution and sale of securities of the Fund, general administration of fund operations and sales and trailing commissions paid to dealers.

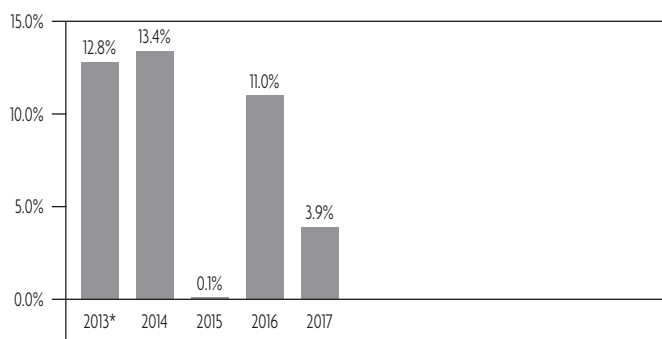
PAST PERFORMANCE

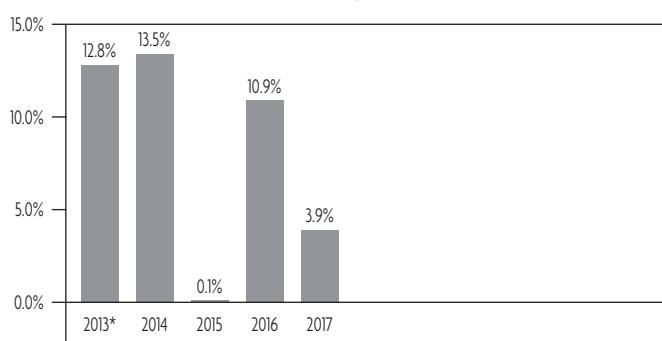
Year-by-Year Returns

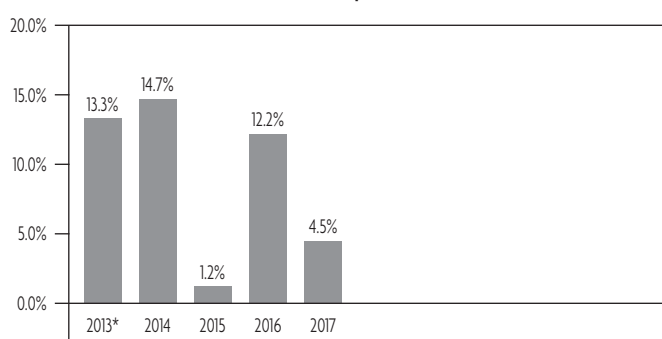
Series A Shares – Annual return for the period ended December 31 and the six month period ended June 30, 2017



Series AT5 Shares – Annual return for the period ended December 31 and the six month period ended June 30, 2017

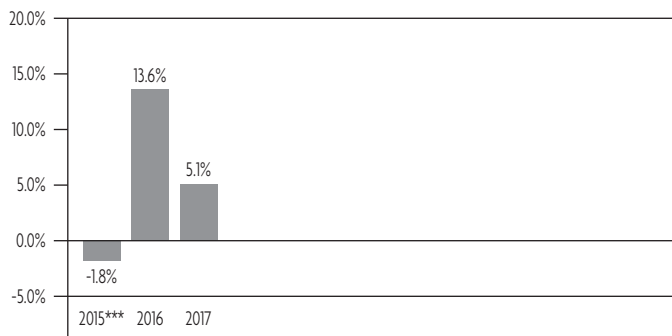


Series F Shares – Annual return for the period ended December 31 and the six month period ended June 30, 2017

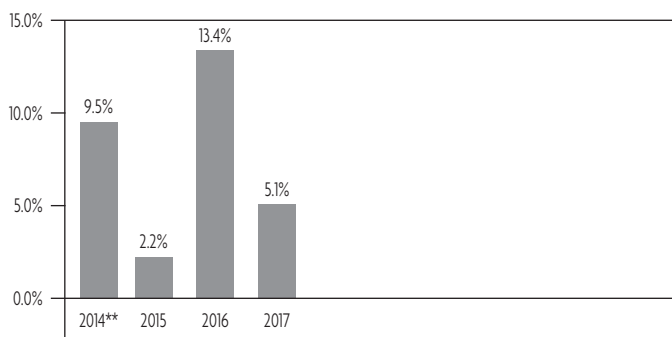
