MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objective and Strategies

The fundamental investment objective of Sun Life BlackRock Canadian Universe Bond Fund (the "Fund") is to provide income by replicating, to the extent possible, the performance, net of fees, of a broad and recognized Canadian bond market index (the "Index"). The fund invests directly in fixed income securities included in the Index and/ or may achieve indirect exposure to some or all of the Index by investing in exchange-traded funds, mutual funds or derivatives that are correlated to the performance of the Index.

The Fund's sub-advisor is BlackRock Asset Management Canada Limited (the "sub-advisor"). The sub-advisor invests the Fund directly in fixed income securities included in the Index and/or may achieve indirect exposure to some or all of the Index by investing in exchange-traded funds, mutual funds or derivatives that are correlated to the performance of the Index. A passive investment strategy is followed and the bonds selected for inclusion in the portfolio will have aggregate investment characteristics such as sector, credit quality, yield and term to maturity similar to those of the bonds comprising the Index.

Risk

There were no changes in the Fund's investment objective or strategy during the period which materially impacted the overall level of risk in the Fund. The risks associated with investing in the Fund remain as outlined in the Fund's Simplified Prospectus.

Results of Operations

During the period, the net asset value of the Fund decreased from \$890.0 million to \$879.5 million. The decrease in net asset value was due to net redemptions, partially offset by positive performance in the period.

During the period, the Fund returned 1.7% for Series I units. This result was in line with the Fund's benchmark, the FTSE TMX Canada Universe Bond, which returned 1.7%. Please refer to the 'Past Performance' section of this report for more details.

For the first half of the period, yields on Canada 10-year benchmark bonds had fallen by nearly 40 basis points ("bps"); 10-year Treasury yields had slipped by more than 70 bps. Furthermore, a remarkable 70% of developed-country government bonds yielded less than 1%, with a third of these securities yielding less than zero.

Towards the end of the year, short term yields stayed anchored, long term yields rose materially following the lead of the U.S. yield curve. Corporate bonds outperformed both Canada and Provincial bonds, supported by further spread tightening as well as their incremental yield advantage.

Recent Developments

Driven by a lack of growth levers, restrained inflation, and entrenched easy monetary policies, it was clear at the beginning of period that bond yields would be under pressure. Market shocks through the first half of the period only intensified that pressure. Early in the first quarter, concerns about growth and potential global recession drove a widespread selloff in equity markets and a flight to safehaven bonds. More recently, the U.K.'s vote in June to leave the European Union ("Brexit") surprised and scared investors, who fled to quality assets – and caused a further decline in yield.

Speculation over the U.S. Federal Reserve rate rise and the U.S. presidential elections dominated markets in the fourth quarter.

The U.S. Federal Reserve raised its benchmark interest rate by 25 bps at the December meeting. Although the raise was anticipated, the tone was more hawkish, signaling towards higher interest rates than expected with the U.S. central bank raising its forecast for the number of further rate increases in 2017 from two to three. Global bond yields sold off in the wake of the surprise U.S. election result and expectations of a reflationary environment as the U.S. shifts from monetary easing to fiscal expansion. The Canadian yield curve steepened, with 10-year yields rising 72 bps while 2-year yields increased by 22 bps. Credit spreads continued their tightening trend as markets were buoyed by the prospect of lighter regulation and fiscal stimulus in the U.S. The Organization of the Petroleum Exporting Countries ("OPEC") agreement to curb oil production also supported credit spreads.

Related Party Transactions

Sun Life Global Investments (Canada) Inc. (the "Manager") is the manager, trustee and portfolio manager of the Fund.

As manager, the Manager is responsible for the provision of all general management and administrative services required by the Fund in its day-to-day operations, including providing or arranging for the provision of investment advice, bookkeeping, recordkeeping and other administrative services for the Fund.

As trustee, the Manager holds legal title to the Fund's investments in trust for unitholders. For its services, the Manager receives a management fee that is calculated as a percentage of the average net asset value of the Fund. This fee is calculated daily and payable monthly.

As portfolio manager, the Manager is responsible for managing the investment portfolio of the Fund directly or through sub-advisors. The Manager has retained BlackRock Asset Management Canada Limited to act as a sub-advisor for the Fund.

The Manager is an indirect wholly owned subsidiary of Sun Life Financial Inc.

During the year, the Manager relied on the approval of the Fund's Independent Review Committee (the "IRC") to enable the Fund to purchase equity securities and non-exchange traded debt securities of Sun Life Financial Inc. ("SLF"), the ultimate parent of the Manager. In accordance with the IRC's approval, before the Fund purchases debt securities of SLF, the Manager is required to ensure that the investment decision (i) is made free from any influence of SLF and does not take into account any consideration relevant to SLF; (ii) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; (iii) is in compliance with the Manager's written policies and procedures relating to the transaction; and (iv) achieves a fair and reasonable result for the Fund.

Fund Administrative Expenses

The Manager pays certain of the operating expenses of each Fund (the "Administration Expenses") in return for a fixed administration fee paid to the Manager by each Fund ("Administration Fee"). The Administration Fee is based on the net asset value of each series of the Fund. The Administration Expenses include, but are not limited to, record keeper fees, accounting, audit and legal fees, bank and interest charges, safekeeping and custodial fees, taxes, administrative and systems costs, costs of reports to investors, prospectuses and other disclosure documents, regulatory filing fees (including those incurred by the Manager) and trustee fees for registered plans. The amount of this charge is disclosed as a fund administrative expense in the Fund's Statement of Comprehensive Income found in the annual financial statements (audited). Each Fund also pays certain operating expenses directly (the "Fund Costs"). Fund Costs include: borrowing costs incurred by the Fund from time to time; costs in connection with portfolio transactions; fees and expenses payable to or in connection with the Fund's Independent Review Committee ("IRC"); taxes payable by the Fund; and the costs of complying with any new regulatory or legal requirement imposed on the Fund. Each Fund allocates Fund Costs proportionately among its series of units. The Fund Costs that are specific to a series of units are allocated to that series. These amounts are paid out of the assets attributed to each series of units of the Fund, which reduces the return you may receive.

Series Description

The Fund offers Series I units only. The date of creation for Series I was April 15, 2011. Series I units are special purpose securities that are currently only available to other mutual funds and eligible institutional investors. Series I units are not sold to the general public. Each Series I investor negotiates its own management and advisory fee that is paid directly to the Manager.

- (4) The Fund's portfolio turnover ratio indicates how actively the Fund's portfolio manager manages its portfolio investments. A portfolio turnover ratio of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a Fund's portfolio turnover ratio in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund.

There is no management fee charged to the Fund.


PAST PERFORMANCE
