MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Results of Operations

During the period, the net asset value of the Sun Life Granite Tactical Completion Fund (the "Fund") decreased from \$554.6 million to \$502.1 million. The decrease in net asset value was attributable to net redemptions as well as negative performance during period.

During the period, the Fund returned -0.6% for Series I units. This result lagged the Fund's benchmark, 34% S&P/TSX 60 C\$, 33% S&P 500 C\$, 27% MSCI EAFE C\$, 6% MSCI EM C\$, which returned 5.8%. Please refer to the 'Past Performance' section of this report for more details.

While generally positive on equities elsewhere, Sun Life Global Investments (Canada) Inc. (the "Manager") moved from neutral to slightly bearish on Canadian markets. The Fund's returns were hindered by the overweight position in Canadian Energy when oil prices fell sharply as crude inventories increased in the period. The Manager is still overweight Canadian Energy, but expects to reduce exposure as oil prices recover. In addition, the Manager used an options strategy to slightly overweight Emerging Market equities, which surged over the last quarter of the period, but may reduce the weighting in the coming months.

Recent Developments

U.S. President Donald Trump took office in the first quarter of 2017 promising to deliver steep, across-the-board tax cuts and a massive economic stimulus program. The Manager believed Trump's economic agenda would be positive for the market and took a moderately bullish position in U.S. equities, which rallied following his election.

Global markets generally did well in the first quarter, with Emerging Market indexes among the strongest performers, which gained when protectionist trade policies proposed by Trump did not materialize. Still, risks remained in Emerging Markets and being selective was critically important.

The Manager continued to be cautious on international markets, due to potential political changes that could undermine the future of the European Union. This included a number of key elections and the U.K.'s decision to start negotiating its withdrawal from the European Union.

The Manager was generally neutral on the Canadian economy but continued to overweight Financials as well as the Energy sector, believing they could benefit from a steepening yield curve and a moderate increase in oil prices.

In the second quarter, President Trump's economic agenda had yet to be implemented. While the market had priced in some of the assumed benefits of his stimulus program, it still appears to be months off and the market is giving less and less weight to the proposals.

However the Manager believes the U.S. economy will improve in the second half of the year, and shifted the investment bias from growth to value (such as Financials), which tend to outperform late in the economic cycle. With uncertainty about Trump's stimulus package, higher valuations and lower potential employment growth, the Manager was cautious on U.S. equities, but remained slightly bullish.

In Europe, political risk is fading, with improved economic growth and a highly-accommodative monetary policy. At the same time, European equities generally have better valuations than U.S. issues.

Related Party Transactions

Sun Life Global Investments (Canada) Inc. (the "Manager") is the manager, trustee and portfolio manager of the Fund.

The Manager is responsible for the provision of all general management and administrative services required by the Fund in its day-to-day operations, including providing or arranging for the provision of investment advice, bookkeeping, recordkeeping and other administrative services for the Fund.

As trustee, the Manager holds legal title to the Fund's investments in trust for unitholders. For its services, the Manager receives a management fee that is calculated as a percentage of the average net asset value of the Fund. This fee is calculated daily and payable monthly.

As portfolio manager, the Manager is responsible for managing the investment portfolio of the Fund directly or through sub-advisor. The Manager has retained Sun Life Assurance Company of Canada, an affiliate, to act as a sub-advisor for the Fund.

The Manager is an indirect wholly owned subsidiary of Sun Life Financial Inc., but Sun Life Assurance Company of Canada is a direct wholly owned subsidiary.

Fund Administrative Expenses

The Manager pays certain of the operating expenses of each Fund (the "Administration Expenses") in return for a fixed administration fee paid to the Manager by each Fund ("Administration Fee"). The Administration Fee is based on the net asset value of each series of the Fund. The Administration Expenses include, but are not limited to, record keeper fees, accounting, audit and legal fees, bank and interest charges, safekeeping and custodial fees, taxes, administrative and systems costs, costs of reports to investors, prospectuses and other disclosure documents, regulatory filing fees (including those incurred by the Manager) and trustee fees for registered plans. The amount of this charge is disclosed as a fund administrative expense in the Fund's Statement of Comprehensive Income found in the semi-annual financial statements (unaudited).

Each Fund also pays certain operating expenses directly (the "Fund Costs"). Fund Costs include: borrowing costs incurred by the Fund from time to time; costs in connection with portfolio transactions; fees and expenses payable to or in connection with the Fund's Independent Review Committee ("IRC"); taxes payable by the Fund; and the costs of complying with any new regulatory or legal requirement imposed on the Fund. Each Fund allocates Fund Costs proportionately among its series of units. The Fund Costs that are specific to a series of units are allocated to that series. These amounts are paid out of the assets attributed to each series of units of the Fund, which reduces the return you may receive.

Series Description

The Fund offers Series I units only. The date of creation for Series I was February 11, 2016.

Series I units are special purpose securities that are currently only available to other mutual funds and eligible institutional investors. Series I units are not sold to the general public. Each Series I investor negotiates its own management and advisory fee that is paid directly to the Manager.

There is no management fee charged to the Fund.


PAST PERFORMANCE
