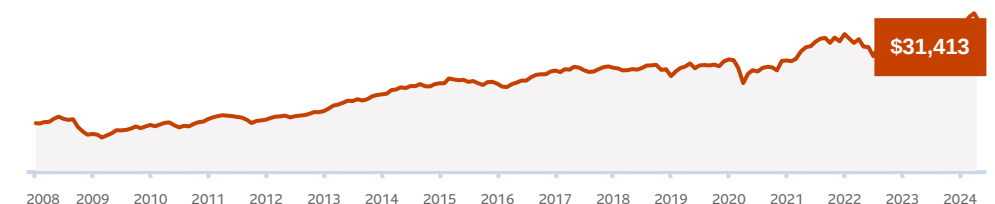


Sun GIF Solutions CI Canadian Equity Estate Series A

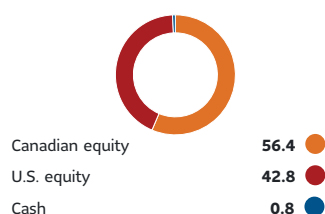

% as of Jan 31, 2024



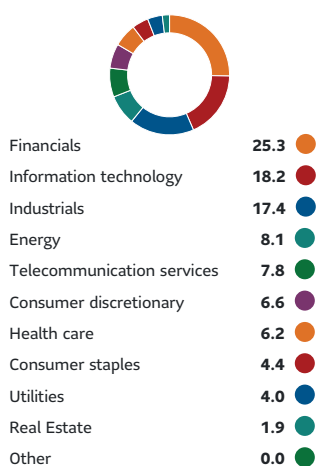
Geographic allocation
