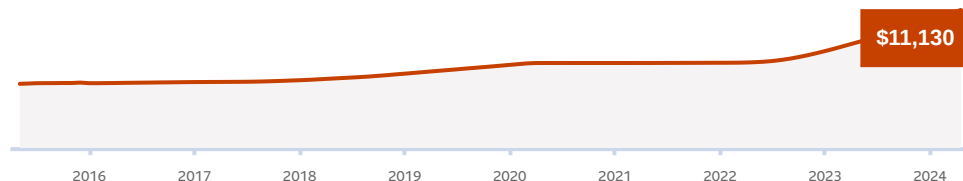


Sun GIF Solutions Daily Interest Estate Series A

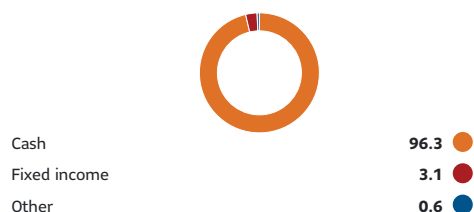
