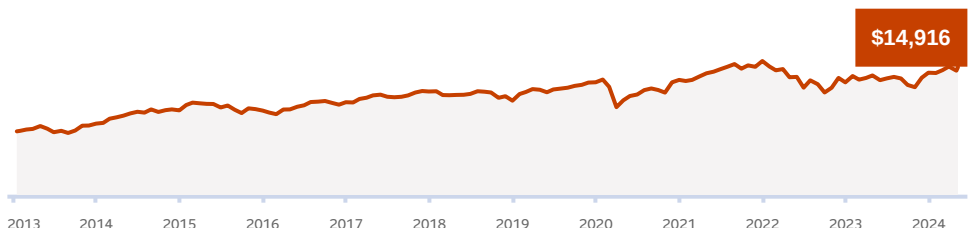


## Sun GIF Solutions Sun Life Granite Enhanced Income Estate Series F
