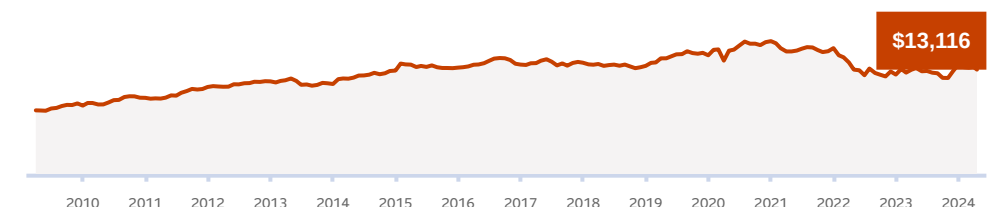


Sun GIF Solutions Sun Life MFS Canadian Bond Estate Series A

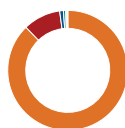
