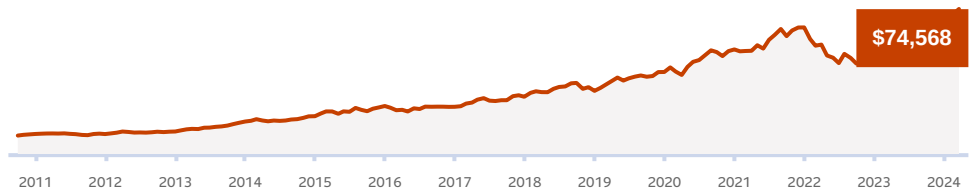

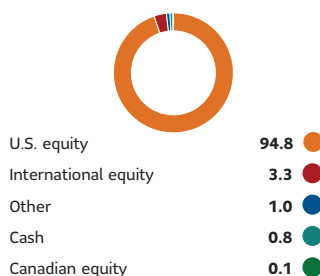

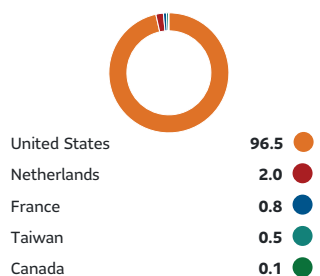
Asset allocation

% as of Jan 31, 2024



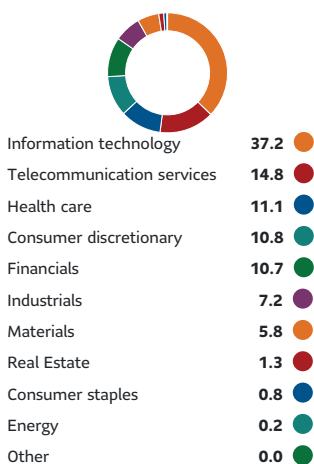
Geographic allocation
