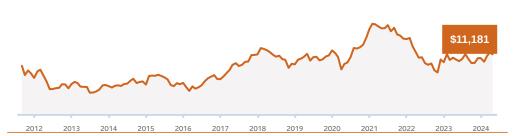


Sun Life Schroder Emerging Markets Fund

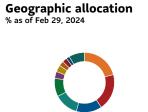
