

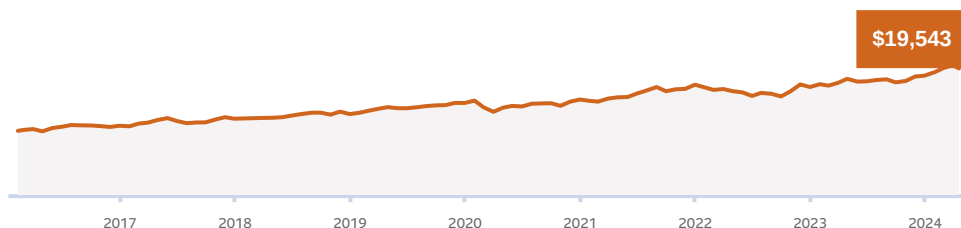
## Sun Life MFS Low Volatility Global Equity Fund
