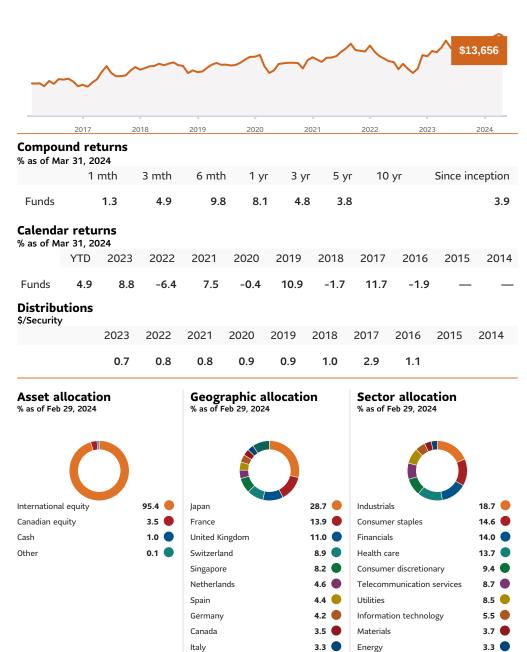


# Sun Life MFS Low Volatility International Equity Fund
