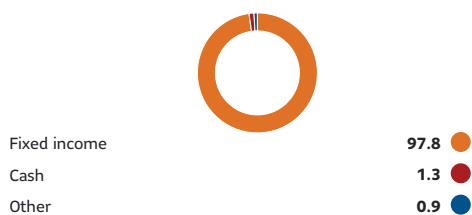

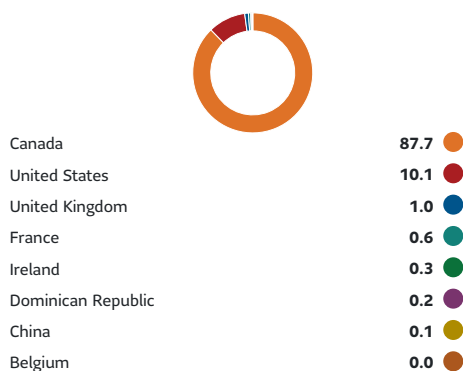
Asset allocation
