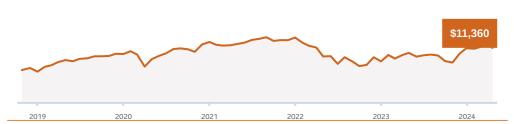


## Sun Life Tactical Conservative ETF Portfolio

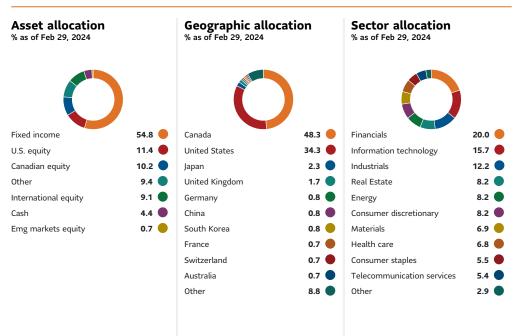
