

**AMENDMENT NO. 3 DATED MAY 20, 2020**

**TO THE SIMPLIFIED PROSPECTUS DATED JULY 18, 2019, AS AMENDED BY  
AMENDMENT NO. 1 DATED NOVEMBER 29, 2019 AND AMENDMENT NO. 2 DATED  
FEBRUARY 26, 2020**

(each a “**Fund**” and collectively, the “**Funds**”)

The simplified prospectus dated July 18, 2019, as amended by Amendment No. 1 dated November 29, 2019 and Amendment No. 2 dated February 26, 2020 (the “**Simplified Prospectus**”) relating to the offering of securities of the Funds is hereby amended as noted below.

Unless otherwise specifically defined, capitalized terms used in this amendment have the meaning given to such terms in the Simplified Prospectus.

**Introduction:**

The Simplified Prospectus is being amended effective June 1, 2020 to reflect that effective the same date:

1. the name of Sun Life MFS International Growth Fund will change to Sun Life MFS International Opportunities Fund; and
2. the name of Sun Life MFS International Growth Class will change to Sun Life MFS International Opportunities Class.

**Technical Amendments to the Simplified Prospectus:**

**1. Name Change for Sun Life MFS International Growth Fund**

Effective June 1, 2020, the name of Sun Life MFS International Growth Fund will change to Sun Life MFS International Opportunities Fund. Effective June 1, 2020, the Simplified Prospectus is amended as follows to reflect this change:

- (a) The references to “Sun Life MFS International Growth Fund” on the front and back covers of the Simplified Prospectus are deleted and replaced with “Sun Life MFS International Opportunities Fund (*formerly, Sun Life MFS International Growth Fund*)”.
- (b) Other than as set out above, all references to “Sun Life MFS International Growth Fund” in the Simplified Prospectus are deleted and replaced with “Sun Life MFS International Opportunities Fund”.

## **2. Name Change for Sun Life MFS International Growth Class**

Effective June 1, 2020, the name of Sun Life MFS International Growth Class will change to Sun Life MFS International Opportunities Class. Effective June 1, 2020, the Simplified Prospectus is amended as follows to reflect this change:

- (a) The references to “Sun Life MFS International Growth Class” on the front and back covers of the Simplified Prospectus are deleted and replaced with “Sun Life MFS International Opportunities Class (*formerly, Sun Life MFS International Growth Class*)”.
- (b) Other than as set out above, all references to “Sun Life MFS International Growth Class” in the Simplified Prospectus are deleted and replaced with “Sun Life MFS International Opportunities Class”.

### **Purchasers’ Statutory Rights**

Securities legislation in some provinces and territories gives securityholders the right to withdraw from an agreement to buy securities of a mutual fund within two business days of receiving the simplified prospectus or fund facts, or to cancel a purchase within forty-eight hours of receiving confirmation of an order.

Securities legislation in some provinces and territories also allows securityholders to cancel an agreement to buy securities of a mutual fund or to get their money back, or to make a claim for damages, if the simplified prospectus, annual information form, fund facts, management reports of fund performance or financial statements misrepresent any facts about the fund. These rights must usually be exercised within certain time limits.
